

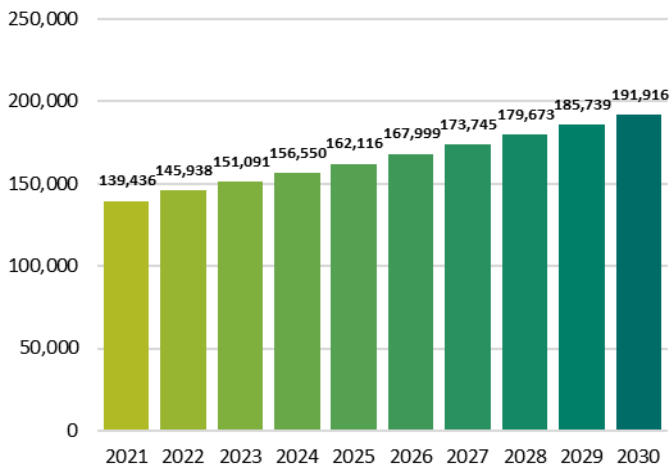

ECONOMIC BENEFITS OF HIGHWAY, STREET, BRIDGE & TRANSIT INVESTMENT

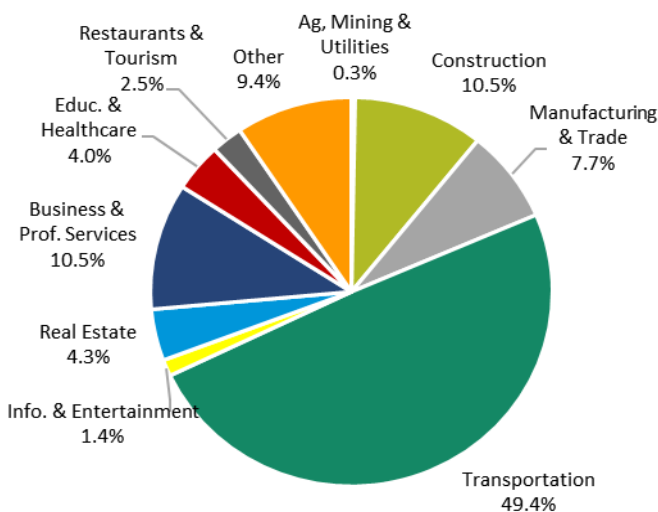
Highway, street, bridge, and transit investment in **Bay Area Region** will support **\$49.0 billion in annual economic output and user benefits over the next decade**, including:

- **\$22.0 billion in business sales**, which supports **165,420 jobs**.
- **\$6.3 billion in wages**, which is included as part of the \$11.1 billion added to the state’s Gross State Product (GSP), measuring total economic output.
- Individuals and businesses contribute **\$6.8 billion in federal, state, and local tax revenue**.
- Transit riders and drivers save an additional **\$13.9 billion/year** due to improvements to the system.

Infrastructure investment has a positive ripple effect throughout the Bay Area Region:

Business sales & output occurs when transportation agencies/construction firms/supplier industries purchase goods & services and hire employees to operate, maintain, and improve local infrastructure.

Employees spend in the county and support additional hiring and spending which generates **tax revenue** from federal, state, and local income, sales and use, and business taxes.

Earnings from workers are part of the value each industry contributes to California’s **Gross State Product (GSP)**, a measure of overall economic output.

Savings for system users occurs as transportation improvements are made; drivers, shippers, and transit riders save money through lower operating costs and travel times, improved safety, and greater network access.

*A job-year of employment is defined as employment for one person for one year. Thus, this number will include people whose jobs are supported over multiple years. For example, if a person is hired in this sector and remains in her position for five years, this is counted as five job-years.
