

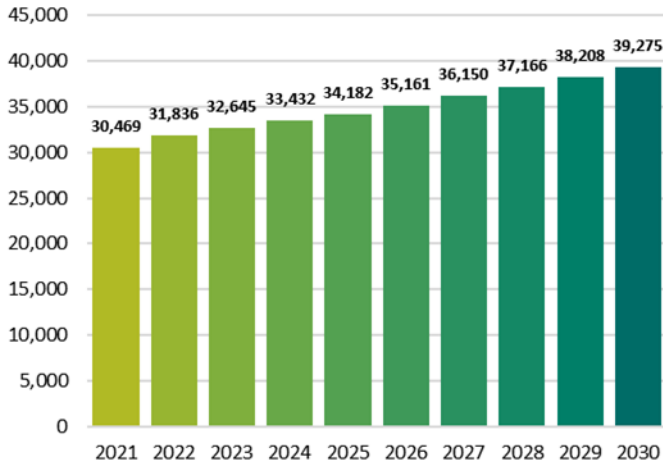
# San Joaquin Valley Region

## ECONOMIC BENEFITS OF HIGHWAY, STREET, BRIDGE & TRANSIT INVESTMENT

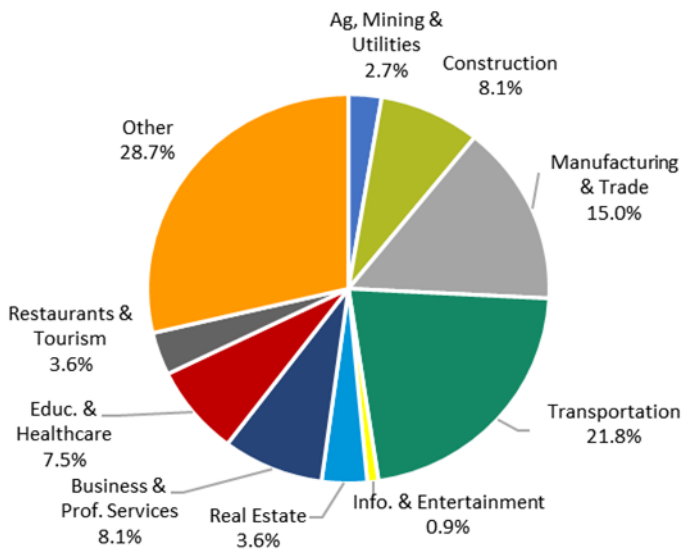
Highway, street, bridge, and transit investment in **San Joaquin Valley Region** will support **\$14.2 billion in annual economic output and user benefits over the next decade**, including:

- **\$7.7 billion in business sales**, which supports **34,852 jobs**.
- **\$1.9 billion in wages**, which is included as part of the \$3.8 billion added to the state's Gross State Product (GSP), measuring total economic output.
- Individuals and businesses contribute **\$1.3 billion in federal, state, and local tax revenue**.
- Transit riders and drivers save an additional **\$3.3 billion/year** due to improvements to the system.

Infrastructure investment has a positive ripple effect throughout the San Joaquin Valley Region:

**Business sales & output** occurs when transportation agencies/construction firms/supplier industries purchase goods & services and hire employees to operate, maintain, and improve local infrastructure.

Employees spend in the county and support additional hiring and spending which generates **tax revenue** from federal, state, and local income, sales and use, and business taxes.

**Earnings** from workers are part of the value each industry contributes to California's **Gross State Product (GSP)**, a measure of overall economic output.

**Savings for system users** occurs as transportation improvements are made; drivers, shippers, and transit riders save money through lower operating costs and travel times, improved safety, and greater network access.

For example, if a person is hired in this sector and remains in her position for five years, this is counted as five job-years.
